### **DIRECTIONS**

Pre-test: to ensure product performance and satisfaction, always pre-test this product in an inconspicuous area. User must determine suitability of product for its intended use.

- 1) Mask off and protect baseboards or adjacent areas not to be treated.
- 2) Liberally apply a coat of Strip Go ® using a chemical resistant roller, paint brush, scrub pad or scrub brush
- 3) For **heavy duty stripping**, allow Strip & Go ® **UNDILUTED** to dwell up to 2 hours without drying or until the sealer or coating softens. **DO NOT** allow Strip & Go ® to dry on the surface by adding more stripper if needed.
- 4) For **light stripping**, dilute Strip & Go ® up to 50/50 with warm or cold water.
- 5) Agitate with scrub brush or buffer with scrub brush or scrub pad.
- 6) Wipe off residue with cotton mop, sponge or white absorbing towel
- 7) Rinse thoroughly with clean water
- 8) Removal of thicker coatings may require additional applications of Strip & Go ®.
- 9) Allow 24 hours before re-applying new sealers or other coatings.

### **MAINTENANCE**

Clean floor regularly with a solution of LAVENET Green
